Shifting Policies, Shifting Ground: Navigating Immigration Policy Changes Affecting the Home Care Workforce

Sally Dreslin, Executive Director, Step Two Policy Project

Shifts in federal healthcare and immigration policy will impact both the delivery of care and the immigrant workforce that sustains it.

In New York, immigrants make up the majority of home care workers, many of whom rely on public programs for health and social needs. Now, some of those programs are under threat.

Legally present immigrants in the workforce are facing additional uncertainty about their authorized status. Even permanent residents and naturalized citizens may feel the ripple effects related to family members who could face detention or deportation.

These policy changes arrive amid a worsening workforce shortage, raising urgent questions about the stability of New York's home care system.

This session will explore the implications of these shifts. Featuring the Executive Director of the Step Two Policy Project, alongside an immigration law expert, the discussion will offer context and guidance for home care providers navigating the intersection of healthcare and immigration policies, employment law, and home care.
